## **Our Response**

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB does hold the information you have requested. NENC ICB has previously held a direct NHS Standard contract with Psych-UK/Psychiatry UK as follows:

- North Cumbria up until 31 March 2023 for an Online ADHD Assessment, Diagnostic & Management Service for adults.
- Newcastle and Gateshead in respect of a waiting list initiative to provide an Online ADHD Assessment, Diagnostic & Management Service for adults for the period 1st October 2022 to 30 September 2023.
- Newcastle and Gateshead in respect of a waiting list initiative to provide an Online Autism Assessment Service for the period 18 October 2021 to 31 March 2023.
- Northumberland in respect of a waiting list initiative to provide an Online ADHD Assessment, Diagnostic & Management Service for adults for the period 1 April 2022 to 31 March 2023.

An urgent award is currently in place with The Owl Centre for a Children and Young People Autism and ADHD Assessment Waiting List Initiative only for 12 months, ending March 2026 with no option to extend.

In accordance with the Information Commissioner's directive on the disclosure of information under the Freedom of Information Act 2000 your request will form part of our disclosure log.
