Freedom of Information Act 2000 - Request for Information - NHS North East and North **Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received by North of England Commissioning Support (NECS) on 8 July 2024 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

Your Request

We are undertaking research into the way in which NHS ophthalmology care, in particular cataract surgery is commissioned by Integrated Care Boards (ICBs) from the independent sector.

We are seeking to understand the extent to which services are commissioned from the independent sector through direct contracts with ICBs or whether they are provided on a noncontract activity basis.

We are also seeking to understand whether optometrists are permitted to make direct referrals to NHS providers (both in the NHS and the independent sector) and if so when this approach was introduced.

As a result, I am asking you to provide the following information under the Freedom of Information Act 2000:

1. For each of the financial years (1 April to 31 March) 2021/22; 2022/23; 20223/24 please provide the names of any independent sector providers that had a **contract** for Ophthalmology services with the ICB.
