Freedom of Information Act 2000 - Request for Information - NHS North East and North **Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received by North of England Commissioning Support (NECS) on 23 July 2024 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

We have dealt with your request in accordance with your "right to know" under section 1(1) of the Freedom of Information Act 2000 (subsequently referred to as FOIA2000) which entitles you to be provided with information "held" by a public authority unless an appropriate exemption applies.

Your Request

I am writing to request the following information in relation to adult autism services under North East North Cumbria ICB.


- 1. Please can you provide the number of referrals to the Adult Autism Diagnostic Services for the years 2019-2024?
- 2. How many people are there currently on the waiting list for Adult Autism Diagnostic Services?
- 3. What is the current pathway for support services provided by the ICB for adult patients following a diagnosis or referral to Adult Autism Diagnostic Services?

Our Response

On this occasion it is not possible to provide the requested information. In line with your rights under section 1(1)(a) of the Act to be informed whether information is held, we confirm the ICB does not hold any of the information requested. However, we have determined that the information is held by mental health hospital foundation trusts within the NENC ICB region.
