<u>Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 23 August 2023 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland and Tees Valley (which covers the 5 councils that make it up – Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

Your Request

My company is doing some research on all new Primary Care Centres/refurbished Primary Care Centres in the last 12 months.

Could you please provide a list of these new properties/the business cases for any relevant properties/developments.

Our Response

County Durham place:

- Dunelm purchase of the building next door and knock through to join together and refurbish the new building
- Byron Medical Practice converting of rooms into clinical rooms

- East Durham Medical Group new lift into the building
- Pinfold Practice additional portacabin on site
- Horden Group Practice refurbishment of 7 clinical rooms
- William Brown Centre conversion of rooms into clinical rooms
- Haven Surgery replacement of flooring and upstands

The above schemes didn't require a full business case and the funding was requested by the GP Practices through the completion of an Expression of Interest template.

Gateshead place:

No new Primary Care Centres or refurbishments in the last 12 months.

Newcastle place:

No new Primary Care Centres or refurbishments in the last 12 months

North Cumbria place:

New development: Carlisle Healthcare, Locke Road, Durranhill Industrial Estate, Carlisle, CA1 3UB. Website: https://www.carlislehealthcare.co.uk/south-carlisle Service opened December 2022.

North Tyneside and Northumberland places:

ICB do not own or manage any Primary Care Centres or health premises. Comprehensive details of all developments and refurbishments would come from our property development partners such as NHS Property Service (see Sunderland place response) and Community Health Partnerships (foi @communityhealthpartnerships.co.uk)

We may have limited details of any recent building completions but not refurbishments.

New development: Hadrian Primary Care Centre, Wallsend new build was completed December 2022. No other new builds or refurbishments of Primary Care Centres.

South Tyneside place:

In South Tyneside the ICB does not own any Primary Care centres. These are leased by GP Practices from other landlords including NHS Property Services and other private/commercial landlords. As such we do not hold any data or information on refurbishments.

Sunderland place:

NENC ICB does not hold the information you have requested within Sunderland place. Please redirect your application to NHS Property Services, using the link NHS Property Services | Freedom of Information

Tees Valley place:

- West View Millennium Surgery replacement of Flooring
- Denmark Street additional Estate for admin staff and the refurbishment of vacated space into clinical space
- Moorlands additional portacabin on site
- South Grange additional portacabin on site

The above schemes didn't require a full business case and the funding was requested by the GP Practices through the completion of an Expression of Interest template.
