**Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received by North of England Commissioning Support (NECS) on 28 March 2024 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the 5 councils that make it up – Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

**Your Request**

I would like to ask the following questions under the Freedom of Information Act. My questions are:

- Does your ICB currently offer patients the weight loss medication Wegovy for adults in line with NICE TA875?
- Has there been any prescriptions of Wegovy to date from Tier 3 weight management services within your ICB since the release of NICE TA875?
- Has the ICB previously offered weight loss medication Saxenda for adults in line with NICE TA664 prior to national supply issues?
- Has there previously been any prescriptions of Saxenda to date from Tier 3 weight management services within your ICB since the release of NICE TA664?
- If the medicines are provided within the ICB, are they available to prescribe within all Tier 3 services in the ICB?
- If the medicines are provided within the ICB, are there any changes to prescribing criteria compared with NICE TA664 and NICE TA875?

It is possible that the volume of material requested is such that it would take it above the cost/staff time limit. If this is the case, then please just focus on the correspondence regarding Wegovy and ignore the Saxenda requests.

With this in mind, I would also respectfully remind you that Section 16 of the FOIA places a duty on public authorities to provide assistance and advice to those making FOI requests so if there are any issues concerning this request – including the research time needed by you to respond – I would expect you to contact me to discuss a way forward.

## **Our Response**

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB does hold the information requested.

- NENC ICB currently offers patients the weight loss medication Wegovy for adults in line with NICE TA875.
- Yes, there have been prescriptions of Wegovy to date from Tier 3 weight management services within NENC ICB since the release of NICE TA875.
- Yes, NENC ICB previously offered weight loss medication Saxenda for adults in line with NICE TA664 prior to national supply issues.
- Yes, there have previously been prescriptions of Saxenda to date from Tier 3 weight management services within NENC ICB since the release of NICE TA664.
- Work is underway to ensure consistent services are provided across all commissioned tier 3 services in the ICB in line with a new service specification. This will ensure prescribing will be delivered by all tier 3 services.
- RDTC for NENC classified both drugs as red thus only available to patients in specialist weight management services (Tier 3 and 4), which is in line with the NICE TA for Saxenda and Wegovy.

In accordance with the Information Commissioner's directive on the disclosure of information under the Freedom of Information Act 2000 your request will form part of our disclosure log. Therefore, a version of our response which will protect your anonymity will be posted on the NHS ICB website <https://northeastnorthcumbria.nhs.uk/>.
