Freedom of Information Act 2000 – Request for Information – NHS North East and North **Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received by North of England Commissioning Support (NECS) on 30 March 2025 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

Your Request

I am writing under the Freedom of Information Act 2000 to request information related to the Independent Oversight Group (IOG) established by the North East and North Cumbria Integrated Care Board (NENC ICB) in October 2023 to oversee the implementation of the Dame Marianne Griffiths review recommendations (published July 2023) concerning the North East Ambulance Service (NEAS).

The IOG, chaired by Graham Prestwich, concluded its work by July 2024, as noted in a Chronicle Live report (24 July 2024). I understand the NENC ICB produced a report on this process, which has not been publicly released.

I request the following:

- 1. The full report produced by the NENC ICB's Independent Oversight Group, chaired by Graham Prestwich, on the implementation of the Griffiths review's 18 recommendations.
- 2. Minutes or notes from IOG meetings held between October 2023 and July 2024.

3. Any correspondence between the NENC ICB, the IOG, and NEAS regarding the implementation of the Griffiths recommendations from October 2023 to July 2024.

This request is in the public interest, given the NEAS deaths scandal's severity, allegations of covered-up patient deaths, whistleblower concerns, and systemic failures, as detailed in the Griffiths review, which criticized NEAS for underreporting Serious Incidents, poor candour, and inadequate investigations.

The IOG's findings, referenced at the NENC ICB board meeting (July 2024), are critical to understanding if these issues were addressed, especially as families expressed disappointment with the process (Chronicle Live, 24 July 2024).

Transparency is vital for accountability, patient safety, and restoring trust in NEAS, a public service. If any information is exempt under the FOIA (e.g., Section 40, personal data), please provide anonymized or redacted versions where possible, with a detailed explanation of each exemption and the public interest test applied.

I believe the public interest in disclosure outweighs exemptions given the scandal's impact. Please acknowledge receipt and respond within 20 working days, as required by the FOIA.

Our Response

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB holds some of the information you have requested.

1. NHS England was responsible for the governance of the Independent Oversight Group and appointing the chair. They also facilitated contact with the families at the beginning, throughout and the end. The administration and organisation of the meetings was largely down to North East Ambulance Service NHS Foundation Trust (NEAS).

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB on this occasion is not able to provide the requested information. In line with your rights under section 1(1)(a) of the Act to be informed whether information is held, we confirm the ICB does not hold any of the information requested. However, we have determined that the information is held by NHS England.
