## **Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received by North of England Commissioning Support (NECS) on 29 August 2023 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland and Tees Valley (which covers the 5 councils that make it up – Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland and Stockton-on-Tees).

### **Your Request**

I am writing to ask if you are able to share the information of how many times you have funded specialist treatment for Dissociative Identity Disorder vs Declined it in the last five years as well as a rough reasoning as to why it was granted if that is possible.

### **Our Response**

One funding request was made in Tees Valley place in 2019. This request was declined.
