<u>Freedom of Information Act 2000 – Request for Information – NHS North East and North</u> <u>Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 17 April 2024 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the 5 councils that make it up – Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland and Stockton-on-Tees).

Please could I ask for the following information related to Personal Health Budgets (Direct Payments) that you are responsible for under NHS North East and North Cumbria Integrated Care Board?

- 1. What is the standard rate set at for carers in Personal Health Budgets (Direct Payments) when calculating a PHB?
- 2. What is the process for determining this rate for carers within a Personal Health Budget (Direct Payment)?
- 3. Which organisation decides / has authority on setting/finalising this rate (e.g. ICB, Local Authority, etc) for Personal Health Budgets (Direct Payments) that you are responsible for under NHS North East and North Cumbria Integrated Care Board?
