Freedom of Information Act 2000 - Request for Information – NHS North East & North Cumbria Integrated Care Board.

Thank you for your request received by North of England Commissioning Support (NECS) on 06 March 2023 for information held by NHS North East and North Cumbria Integrated Care Board (ICB) under the provisions of the Freedom of Information Act 2000.

For information Clinical Commissioning Groups ceased to exist on 30 June 2022. Services that were previously delivered by the CCG are now being delivered by the successor organisation NHS North East and North Cumbria (ICB). This covers the areas of County Durham, Newcastle Gateshead, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland and Tees Valley.

Please find the information you requested on behalf of the ICB as follows.

- 5. Please detail actual spend on each contract/framework for diagnostic services, from the start of the contract to the current date and annually.
- 6. What was the start date & duration of framework/contract/award?
- 7. Could you please provide a copy of the service/product specification given to all bidders for when this contract was last advertised?
- 8. Is there an extension clause in the framework(s)/contract(s) and, if so, the duration of the extension?
- 9. Has a decision been made yet on whether the framework(s)/contract(s) are being either extended or renewed?
- 10. Who is the senior officer (outside of procurement) responsible for this contract? (Internal note: By this the applicant means the member of staff at the ICB who the key stakeholder for community diagnostic services procurement is. If we cannot name the individual, please provide their job title.)
