Freedom of Information Act 2000 – Request for Information – NHS North East & North Cumbria Integrated Care Board (ICB)

Thank you for your request received by North of England Commissioning Support (NECS) on 08 February 2023 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

For information Clinical Commissioning Groups ceased to exist on 30 June 2022. Services that were previously delivered by the CCG are now being delivered by the successor organisation NHS North East and North Cumbria (ICB). This covers the areas of County Durham, Newcastle Gateshead, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland and Tees Valley.

Details of Request and Reply

I am seeking information about your health and social care trust's network of providers. To better understand your digital capabilities, infrastructure, and integration, I'm seeking answers to the following questions:

We are not a Trust, however, have responded on behalf of the ICB.

- Do you have plans in place for integrating data systems between primary, community, and secondary care?
 Yes – key system for information/record sharing will be via the Great North Care Record (GNCR).
- Do you have a baseline mapping of your digital infrastructure in place? Not at a system level, but each organisation will have a digital maturity level understanding, a system level digital maturity assessment (DMA) is being planned.
- Do you have a public facing digital strategy? Yes – available on the NHS North East and North Cumbria (NENC) ICB website <u>https://northeastnorthcumbria.nhs.uk/media/5jdnarmg/nenc-ics-digital-strategy-2020_v1-2-3.pdf</u>

- Do you use patient initiated follow-up (PIFU) processes or technology? Yes – within individual NHS NENC provider organisations.
- Do you employ the following roles in your health system? If yes, approximately how many?
 - 1. Chief System Integration Officer Not within the NENC ICB.
 - 2. Director of Digital Products Not within the NENC ICB.
 - 3. Director of Analytics Yes within the NENC ICB (1), provider organisations may have equivalents also.
 - 4. Digital Lead/Director Yes within the NENC ICB (1), provider organisations will have equivalents.
 - 5. Director of Partnerships Not within the NENC ICB digital portfolio.
 - 6. Head/Director of Digital Solutions Not within the NENC ICB.
 - 7. Head/Director of Digital Innovation Not within the NENC ICB, but similar roles may exist within the wider system.
 - 8. Head/Director of Digital Transformation Yes within the NENC ICB (1).
 - 9. Head/Director of System Strategy Not within the NENC ICB digital portfolio, but an ICB Executive role does exist (1).
 - 10. Head/Director of Integration Not within the NENC ICB digital portfolio.
 - 11. Head/Director of Transformation Not within the NENC ICB digital portfolio.
 - 12. Head/Director of System Partnerships Not within the NENC ICB digital portfolio.
 - 13. Data Scientist Not within the NENC ICB.
 - 14. Data Analyst Yes, such roles exist within the NENC ICB and its commissioning support service provider.
 - 15. Head/Director of Data Science/Artificial Intelligence Not within the NENC ICB.
 - 16.Other roles related to innovation and/or transformation N/A
