**Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received by North of England Commissioning Support (NECS) on 11 April 2024 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the 5 councils that make it up – Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

**Your Request**

The questions below which I would like you to answer are designed to help me understand:

- how much money your integrated care board (ICB) spent on hospice services for children and young people with life-limiting or life-threatening conditions in 2023/24
- how many children and young people with life-limiting or life-threatening conditions in your ICB footprint accessed hospice care during 2023/24
- how much money your integrated care board (ICB) plans to spend on hospice services for children and young people with life-limiting or life-threatening conditions during 2024/25, excluding the £25 million Children's Hospice Grant funding that NHS England has asked every ICB to distribute.

In order to help you meet my request, I provide definitions to the terms I use in my questions below:

***Life-limiting and life-threatening conditions***

“Life-limiting conditions are those for which there is no reasonable hope of cure and from which children will die. Some of these conditions cause slow deterioration over time rendering the child increasingly dependent on parents and carers.

Life-threatening conditions are those for which curative treatment may be feasible but can fail, such as cancer.

### ***Children and young people***

Babies, children and young people aged 0-25.

### **My questions**

1. Please set out how much money your integrated care board spent on hospice care for children and young people with life-limiting or life-threatening conditions between 6 April 2023 and 5 April 2024. Please provide a total, in addition to a breakdown of funding per children’s hospice organisation.
2. Please set out the arrangement through which this money was paid in 2023/24 – was this by standard contract, service level agreement, grant arrangement, spot purchases or by other means.
3. Please set out how many children and young people with life-limiting or life-threatening conditions who live in your integrated care board footprint accessed hospice care between 6 April 2023 and 5 April 2024. Please provide a total, in addition to a breakdown of funding per hospice organisation.
4. Please set out how many children and young people with life-limiting or life-threatening conditions who live in your integrated care board footprint could benefit from children’s hospice care.
5. Please set out how much money your integrated care board plans to spend on hospice care for children and young people with life-limiting or life-threatening conditions between 6 April 2024 and 5 April 2025, excluding any money that is set to be paid as part of the NHS England Children’s Hospice Grant. Please provide a total, in addition to a breakdown of funding per hospice organisation.
6. Please set out the arrangement through which this money will be paid in 2024/25 – by standard contract, service level agreement, grant arrangement, spot purchases or by other means.

### **Our Response**

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB holds some of the information you have requested.

On this occasion it is not possible to provide the requested information. In line with your rights under section 1(1)(a) of the Act to be informed whether information is held, we confirm the ICB does not hold any of the information requested.

The ICB places above contract hospices as overall indicative block values which is not split between adults and children. However, we have determined the records are held by the individual hospices listed below.

#### Northumberland place

On this occasion it is not possible to provide the requested information. In line with your rights under section 1(1)(a) of the Act to be informed whether information is held, we confirm the ICB does not hold any of the information requested for Northumberland ICB place.

Northumberland place contract our hospices with Northumbria Healthcare NHS Foundation Trust (FT) and only have an overall indicative block value for all hospices which is not split between adults and children.

The North East and North Cumbria Integrated Care Board (NENC ICB) does not hold the records which you have sought. However, we have determined the records are held by Northumbria Healthcare NHS FT.

#### Sunderland place
