Clinical Chair for the Alliance has just stepped down but it was Mike Reed, Clinical Director, Trauma & Orthopaedics, Northumbria Healthcare NHS Foundation Trust. The Co-Chair who is still in situ is Diarmaid Ferguson, Advanced Physiotherapy Practitioner, Northumbria Healthcare NHS Trust. Recruitment of a T&O Consultant Surgeon will be planned to replace Mike Reed should funding be obtained.

The posts have been funded by the ICB (certainly for this year). The ongoing continuation of funding is being discussed.

6. What are the priorities for MSK service development for the ICS?

Currently within the MSK Alliance Terms of reference outlines it's priorities and objectives: Elective Care Transformation is required to ensure patients needing planned care see the right person, in the right place, first and every time, and get the best possible outcomes, delivered in the most efficient way;

- better manage rising demand for elective care services
- improve patient experience and access to care
- provide more integrated, person-centred care

We will work closely with partners including Getting It Right First Time to help NENC transform their elective care services and align their priorities.

Alliance aims and objectives (agreed at the outset);

- Empowering the established networks to make change
- Providing relevant data and data support Provision of focussed data across the established networks will allow greater concentration on areas of variation and increased performance and patient outcomes
- Reducing low volume procedures / Promoting highly specialised care when needed. This
 will provide equity of access for patients and reduce variation in access and outcomes
 resulting in providing better care for patients
- Improvement collaboratives
- Sharing data / sharing ideas
- Joint Procurement which will save money for trusts and the NHS
- Supporting and dovetailing with the pre-secondary care initiatives
- Referral pathways / mechanisms
- Reducing surgery that's questionable

With the MSK Alliance recently being passed over to the Provider Collaborative to support. The Alliance have discussed their work plan moving forwards and reviewing this in alignment with the refreshed Strategy for Elective Care signed off by the Strategic Elective Care Board for NENC.
