

Thresholds – The Public Contracts Regulations 2015 (as amended)

When procuring goods or services over the set financial thresholds a Contracting Authority must consider their obligations under the Public Procurement (Agreement on Government Procurement) (Thresholds) (Amendment) Regulations 2021 (SI 2021/1221).

Health / NHS organisations are also required to comply with the Procurement, Patient Choice and Competition (No 2) Regulations 2013 when advertising for services.

The Cabinet Office announced revised threshold limits for public procurements on 01 November 2021. The revised limits apply to all contract opportunities arising from 01 January 2022.

On the face of it the threshold amounts will be increased, but the estimated value of procurements will now be inclusive of VAT instead of net of VAT. This means that contracting authorities will need to consider if the requirement is subject to VAT, and if so, at what level, before knowing what the threshold is.

The Light Touch Regime threshold will not of itself be amended. However, the Light Touch regime threshold will now also become inclusive of VAT.

A services contract will fall within the scope of the Light Touch regime if it is for the certain types of health, social and other services listed at Schedule 3 of the PCR 2015. If a service is not listed at Schedule 3 of the PCR 2015 it will be subject to the full regime rather than the Light Touch regime.
