Report Title:	Constitution of the NHS North East and North Cumbria Integrated Care Board

#### **Purpose of report**

To present the Board with an updated Constitution for the North East and North Cumbria Integrated Care Board (the ICB).

# **Key points**

The Health and Care Act 2022 (the Act) established integrated care boards as part of integrated care systems on 1 July 2022. The aim of the Act was to bring health and care organisations together to provide greater opportunities for collaboration and a shared responsibility for health of local populations in the planning and delivery of services to tackle health inequality and improve quality and outcomes.

The NHS North East and North Cumbria Integrated Care Board (the ICB) is the statutory decision-making body for the commissioning of health services and responsible for the effective stewardship of NHS spending for all the people living in the North East and North Cumbria.

The Constitution and supporting documents set out the framework for the ICB to delegate decision-making authority, functions and resources. The Constitution is fully compliant with NHS England requirements and was formally approved by NHS England on 27 May 2022. The latest version of the Constitution was approved by the Board at its meeting on 30 May 2023 and approved by NHS England on 23 November 2023.

Recent publication of the NHS England Guidance PAR1551 sets out several amendments now needed to the ICB constitutions. A summary of the main changes in the guidance is set out below:

- The removal of clauses relating to the "establishment" of the ICB
- Board Membership 2.2.3 The appointment of a "Deputy Chair" from Non-executive Members (one of which, but not the Audit Committee Chair, will be appointed Deputy Chair)
- Chair 3.3.4 The term of office for the Chair will be a maximum of three years and the total number of terms a Chair may serve is three terms. The term of "Deputy Chair" must align with Chair appointment in role.
- Deputy Chair 3.4.1 The Deputy Chair is to be appointed from amongst the Non-executive members by the Board subject to the approval of the Chair.
- (4.2.2) If the Chair is absent or is disqualified from participating by a conflict of interest, (the Deputy Chair shall preside over meetings in the Chairs stead.
  (4.2.3) If both the Chair and Deputy Chair are absent or disqualified from participating by a Conflict of Interest there may be a provision for the assembled members to appoint a temporary deputy from the remaining Non-Executive members for the purpose of chairing the meeting.
- A small number of cross-reference changes to other legislation.

Some additional updates have also been made to the ICB Constitution to reflect the changes in line with the revised ICB 2.0 transformation programme of the Executive Team structure and conclusion of the consultation regarding portfolios which will come into effect from 01 April 2024.
