Freedom of Information Act 2000 - Request for Information - NHS North East and North **Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received on 9 September 2025 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000. The ICB covers the areas of County Durham, Newcastle Gateshead, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley.

 - whether the services are delivered under a General Dental Services contract, Personal Dental Services contract, or other arrangement
- 3. If no Tier 2 dental commissioning has taken place, please confirm if the ICB has any plans, consultations, or discussions underway regarding future Tier 2 dental commissioning.
