**Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received on 15 December 2025 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000. The ICB covers the areas of County Durham, Newcastle Gateshead, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley.

Please find the information you requested on behalf of the ICB as follows.

**Your Request**

Thank you again for the information you provided in fulfilment of FOI reference FOI ICB 25-109 supplied on 02/07/2025.

I have now received responses and data from over 600 public bodies. Many have, without prompting, included additional fields beyond those originally requested, which add helpful context to late payment data.

I'm writing to ask whether any of the following fields (or similar) are already available within your system, and if so, whether you could add them to the dataset you previously provided under FOI reference FOI ICB 25-109 supplied on 02/07/2025.

Providing the date you received the invoice would be a really useful addition as would any of the other examples below:

- Invoice due date
- Invoice approved date
- Invoice payment terms
- Invoice query/dispute flag, e.g. Y/N

- Reason for invoice query/dispute/delay

I want to emphasise that I do not wish to create any additional work. I'm only asking for this information if it already exists in your system and can be exported easily alongside the information you've already supplied. If these fields are available and can be shared, I'd be very grateful if you could provide them (even if this means treating it as a new request). If not, please just let me know and I'll make a note — there's no need to take any further action.

## **Our Response**

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB holds some of the information you have requested.

The attached spreadsheet includes information for financial years 2022/23, 2023/24, 2024/25 and 2025/26 to date. NENC ICB cannot provide the approval date or reason for dispute or query as this detail is not included in the reports that the ICB is able produce.

In accordance with the Information Commissioner's directive on the disclosure of information under the Freedom of Information Act 2000 your request will form part of our disclosure log.
