<u>Freedom of Information Act 2000 – Request for Information – NHS North East and North</u> <u>Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 9 March 2024 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the 5 councils that make it up – Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

Your Request

Please could I ask for the following information related to Young Adults (18-25) with EHCP/Joint Packages from NHS North East and North Cumbria Integrated Care Board?

- 1. For Q3 2023/24 Total number of adults (from 18-25) who have Personal Health Budget with an EHCP in place?
- 2. From the above (1) cases, how many have an Integrated Budget?
- 3. From the above (2) cases, how many are classified as Direct Payments / 3rd party / Notional?
- 4. From the above (2), what is the split (%) for Lead Commissioner (i.e. ICB, Local, Authority, etc.).
