## Freedom of Information Act 2000 - Request for Information - NHS North East and North **Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received on 13 May 2025 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000. The ICB covers the areas of County Durham, Newcastle Gateshead, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley.

Please find the information you requested on behalf of the ICB as follows.

## **Your Request**

Under the Freedom of Information Act 2000, I am requesting information regarding NHS North East and North Cumbria ICB's expenditure on insourcing and outsourcing of services for the financial year 2024/25 (April 1, 2024, to March 31, 2025). Specifically, please provide the following:

- 1. The total amount spent by NHS North East and North Cumbria ICB on insourcing services. defined as the employment of third-party providers to perform medical or clinical services on NHS premises, typically out-of-hours, using NHS equipment (e.g., to address waiting lists).
- 2. The total amount spent by on outsourcing services, defined as contracting services to external providers, typically off-site (e.g., private healthcare providers, IT services, or other non-NHS entities).
- 3. If available, a breakdown of the above spends by service type or provider (e.g., clinical services, administrative services, specific suppliers), including any contracts or framework agreements used.
- 4. If exact figures for the full 2024/25 financial year are not yet available, please provide the most recent data (e.g., up to the latest quarter) or provisional figures.

If NHS North East and North Cumbria ICB do not hold this information (e.g., if data is managed by NHS trusts or other entities), please confirm this and, if possible, direct me to the appropriate

organisation(s). If any part of this request is exempt under the FOI Act, please provide the available data and explain the exemption.

## **Our Response**

On this occasion it is not possible to provide the requested information. In line with your rights under section 1(1)(a) of the Act to be informed whether information is held, we confirm the ICB does not hold any of the information requested. This is clarified in the paragraphs below.

NENC The ICB is a commissioning organisation, not a provider of services, and does not insource the provision of medical or clinical services on NHS premises. We commission a range of providers, both NHS and non-NHS organisations, to deliver healthcare services. As part of our contracts with NHS providers, they may choose to sub-contract or insource services from third-party providers, but the ICB would not hold that information.

As noted above, the ICB is a commissioning organisation, not a provider of services, and almost all of the ICB's funding allocation is used to commission healthcare services from external providers, including both NHS and non-NHS organisations. We would not consider this to represent 'outsourcing' of services as the ICB is not a provider of services. If further information is required, please provide a clear definition of what you mean by outsourcing services in the context of the ICB.
