**Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received by North of England Commissioning Support (NECS) on 3 April 2024 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the 5 councils that make it up – Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

**Your Request**

I am writing to you under the Freedom of Information Act (2000), to request the following information.

Please provide me with data for the years 2022-2023 and 2024 (if available) for the following information for data relating to Ophthalmology services across the ICS.

Please break down all information by category relating to Ophthalmology treatment code 130. Include all activity against codes WF01A, WF01B, WF02A, WF02B.

The total number of patients referred for ophthalmology treatment in the last 12 months
Please breakdown all information by category relating to Ophthalmology treatment code 130. Include all activity against codes WF01A, WF01B, WF02A, WF02B
Inpatients
Outpatients
For inpatient treatment, total admissions per month, average length of stay, number of admissions by day of week per month and discharges by day of week per month

Total referrals from Primary Care and originating ICS by month, Total wait for first appointment, total new, follow up (as above) and then total wait to first appointment and total wait for follow up appointment, number of patients currently waiting for first appointment and number waiting for follow up appointment
Number of patients who had first appointment cancelled and re-referred to another provider
Number of patients in point 5 who were referred to another NHS provider
Number of patients in point 5. who were referred to Private Provider

## Our Response

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB holds some of the information you have requested. This is detailed in the attached spreadsheet.

Please note that your request asks for data relating to Ophthalmology services across the ICS. The data provided relates to our ICB patients irrespective of whether treatments/ attendances take place within the boundary of the ICB. Similarly, activity at local ICB providers will cover more than our ICB patients. A full picture of activity at local ICB providers would need to come from the providers themselves.

In accordance with our duty under s.16 of the FOIA to provide reasonable advice and assistance to an individual requesting information, we have provided the FOI email addresses for those acute hospitals to make your request.
