<u>Freedom of Information Act 2000 – Request for Information – NHS North East and</u> <u>North Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 05/02/2024 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the 5 councils that make it up – Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

Your Request

Some ICBs have set limits on the BMI of both female and male partners who are seeking IVF / ICSI treatments. For example, some have set this at 18-25, others 18-30. Values outside of these ranges prevent couples from accessing these treatments.

Can you advise if a) you have such a policy and b) what the relevant BMI range is to be eligible to access treatments?

Our Response
