**Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received by North of England Commissioning Support (NECS) on 11 December 2024 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

**Your Request**

I am writing to you under the Freedom of Information Act 2000 to request the following information from your ICB. The questions relate to brain injury rehabilitation services. I am seeking baseline information from commissioners to understand the EDI characteristics of the populations you serve and the referrals that are made to brain injury services. Please could you provide me with an answer to the following:

1. Please could you give a percentage breakdown of the population of your ICS by ethnicity?
2. How many onward referrals did you make/your CHC panel approve for inpatient/residential brain injury rehabilitation for persons with an acquired brain injury such as Stroke, Traumatic Brain Injury, or Brain Infections in 2023/24?
3. Please could you provide a breakdown of which providers these referrals were sent to, and whether that provider was in or out of your ICB area?
4. Of the referrals for brain injury in 2023/24, please could you provide a percentage breakdown by ethnicity?
5. Do you routinely monitor the ethnicity of referrals for brain injury to see whether they are in line with expected prevalence? If so, please provide any monitoring data on this where available?

If it is not possible to provide the information requested due to the information exceeding the cost of compliance limits identified in Section 12, please provide advice and assistance, under the Section 16 obligations of the Act, as to how I can refine my request.

## **Our Response**
