Thank you for your request received on 2 April 2025 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000. The ICB covers the areas of County Durham, Newcastle Gateshead, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley.

Please find the information you requested on behalf of the ICB as follows.

Your Request

- 1. Which Secure Data Environment (SDE) infrastructure/design are you using to ensure that outputs are only made available via the "safe outputs" process? (If any may be something custom? the HDR/DARE mess? regular AWS/Azure remote environments?).
- (If you're using the <u>HDR</u>/DARE technical platform, can you please explicitly confirm whether you've taken all steps to disable the <u>"deception by design" "features"</u> from HDR which let <u>anyone</u> (with a linkedin account) go via the HDRgateway to run arbitrary analyses on your data (the feature should never have been added, and you will require a specific audit give confidence that it is entirely disabled)).

Our Response

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB holds some of the information you have requested.
