For information Clinical Commissioning Groups ceased to exist on 30 June 2022. Services that were previously delivered by the CCG are now being delivered by the successor organisation NHS North East and North Cumbria (ICB).

- Please can you provide one figure, taking in the total discharges from your NHS trust.
- Please can I also be provided with the figures for the number of people <u>without a fixed</u> <u>abode</u> who were readmitted within six months.
- Can you please provide this data in the same way as above.
