Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)

Thank you for your request received by North of England Commissioning Support (NECS) on 24 November 2023 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland and Tees Valley (which covers the 5 councils that make it up – Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

Your Request

Under the Freedom of Information Act 2000 I would like to request the following information:

- The amount owed by overseas patients to the North East and North Cumbria NHS Integrated Care Board (or the equivalent organisation) over the last five calendar years (broken down by year, 2023, 2022, 2021, 2020, 2019)
- The breakdown of this data by where the overseas patients are from, how much they owe and how much gets written off.

Our Response

There will be no sums owed to North East and North Cumbria Integrated Care Board (NENC ICB), as the ICB does not charge overseas patients. As such, NENC ICB does not hold the records which you have sought. However, we have determined the records are held by Acute Hospital NHS Foundation Trusts within the North East and North Cumbria region.

In accordance with our duty under s.16 of the FOIA to provide reasonable advice and assistance to an individual requesting information, we have provided the FOI email addresses for those acute hospitals to make your request.
