Freedom of Information Act 2000 – Request for Information – NHS North East and North **Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received on 6 October 2025 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000. The ICB covers the areas of County Durham, Newcastle Gateshead, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley.

Please find the information you requested on behalf of the ICB as follows.

Your Request

I am writing to request the following information under the Freedom of Information Act 2000. Could I please request information regarding the commissioning of GP Out of Hours services in your region. The specific things I am interested in are as follows:

- 1. Who is the current provider of these services?
- 2. Which GP Out of Hours services went through procurement, and which were a direct award?
- 3. What is the actual spend on this contract from the start of the contract to the current date?
- 4. What is the start date and duration of the contract?
- 5. Is there an extension clause in the framework(s)/contract(s) and, if so, what is the duration of the extension?
- 6. Has a decision been made yet on whether the contract(s) are being either extended or renewed?
- 7. Is there an aim to go out to procurement for this service? If so, when do you envisage this occurring?
