## <u>Freedom of Information Act 2000 – Request for Information – NHS North East and</u> <u>North Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 02 May 2023 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland and Tees Valley.

Please find the information you requested on behalf of the ICB as follows.

## Your Request

Please could you restrict the search to:

Meeting minutes, informal notes and emails between your organisation and Academic Health Science Networks (AHSNs) and the Department for Health (if applicable) in connection with the medication Inclisiran

## **Our Response**

As with your previous request, NENC ICB would like clarity whether the definition of emails sent or received would mean by the Medicines Optimisation team. It will not be possible to access all emails sent across the ICB in relation to Inclisiran. The ICB estimates that the cost of complying with your request would exceed the appropriate limit.

The ICB estimates that a manual exercise to retrieve this information would exceed the appropriate limit set out in section 12(1) (cost limit) of the Freedom of Information Act 2000. Currently this is set at £450 for the ICB, which equates to 18 hours or more of an officer's time.

It is difficult to accurately estimate the amount of time it will take. Each individual place within ICB will need to carry out this exercise. For whole ICB this could be 8 x 10hours = 80hours. The reason for the amount of time is that emails sent and received from a number of different email addresses will need to be searched and by a wide range of people. Then it all needs to be saved to a single folder. Searching just for AHSN will not cut down the time taken as a number of different people within AHSN may have had correspondence with ICB.

Under the Section 16 duty to provide advice and assistance, the CCG may be able to comply with a refined request. For example, if the request were to be limited to formal documentation at meetings, inclusion in work plans or training events this would be more manageable within the FOI timescale requirements. Supplying minutes of formal meetings and publications on websites would considerably reduce the time required and allow us to respond within the appropriate limit.

In line with the Information Commissioner's directive on the disclosure of information under the Freedom of Information Act 2000 your request will form part of our disclosure log. Therefore, a version of our response which will protect your anonymity will be posted on the NHS ICB website <a href="https://northeastnorthcumbria.nhs.uk/">https://northeastnorthcumbria.nhs.uk/</a>.

If you are unhappy with the service you have received in relation to your request and wish to make a complaint or request a review of our decision, you should write to the Senior Governance Manager using the contact details at the top of this letter quoting the appropriate reference number.

Generally, the Information Commissioner cannot make a decision unless you have exhausted the complaints procedure provided by the North of England Commissioning Support Unit.
