<u>Freedom of Information Act 2000 – Request for Information – NHS North East and North</u> <u>Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 6 January 2025 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

Your Request

Can I ask what information you hold, e.g. policies/procedures, as to in what circumstances a hospital can decline a referral from a GP for further investigations.

I am particularly interested in what the policies/procedures say in regard to patients where three separate GP's raise concerns regarding a patient's chest pains, exhaustion, and other symptoms which they feel needs cardiac investigation, but where this referral is not accepted by a hospital.

Our Response

On this occasion it is not possible to provide the requested information. In line with your rights under section 1(1)(a) of the Act to be informed whether information is held, we confirm the ICB does not hold any of the information requested.

The ICB does not have a written policy on when a hospital can decline a referral from a GP for further investigations; the secondary care contract covers that situation.

The ICB has however taken legal advice on the rejection of referrals in the context of the contract and has been advised that trusts can decline referrals if clinical thresholds have not been reached.
