## <u>Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 28 June 2023 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland and Tees Valley (which covers the 5 councils that make it up – Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland and Stockton-on-Tees).

Please could you provide information regarding the review process for the patient pathways and booking procedures used by CDC?

## **Our Response**

The NENC CDC programme is delivering three new facilities across the ICS – one in North Cumbria, one in Teesside and one in Gateshead.

The patient pathways are being developed by the clinical teams to meet local needs and to align with adjacent services. Booking procedures are currently an expansion of those in place for local acute and community services, over the next 18 months the NENC ICS diagnostic digital programme will deliver an integrated, ICS-wide referral and reporting solution for diagnostic services across CDCs, acute and community settings.
