The integration solution that supports the regional Shared Care Record (known as the Great North Care Record), is a Health Information Exchange (HIE) provided by Oracle Cerner and hosted on behalf of the North East and North Cumbria (NENC) regional by Newcastle Hospitals NHS Foundation Trust
