Freedom of Information Act 2000 - Request for Information - NHS North East and North **Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received by North of England Commissioning Support (NECS) on 14 March 2024 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the 5 councils that make it up - Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

Your Request

I am writing to request the following information under the Freedom of Information Act:

- 1. The median length of time from referral to autism services to receiving an autism assessment in the North East and North Cumbria for children.
- 2. The median length of time from referral to autism services to receiving an autism assessment in the North East and North Cumbria for adults.
- 3. The median length of time from referral to autism services to receiving the final outcome of an autism assessment (i.e. a positive or negative diagnosis) in the North East and North Cumbria for children.
- 4. The median length of time from referral to autism services to receiving the final outcome of an autism assessment (i.e. a positive or negative diagnosis) in the North East and North Cumbria for adults.
- 5. The conversion rate of autism assessments to autism diagnoses in the North East and North Cumbria for children.
- 6. The conversion rate of autism assessments to autism diagnoses in the North East and North Cumbria for adults.
- 7. What support and further referral is routinely offered to children who receive an autism diagnosis through North East and North Cumbria ICS.

- 11. What standardised tools are currently used in the North East and North Cumbria for the screening and/or triage of children who seek an autism assessment.
- 12. What standardised tools are currently used in the North East and North Cumbria for the screening and/or triage of adults who seek an autism assessment.

Our Response

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB holds some of the information you have requested.

County Durham and Tees Valley places

On this occasion it is not possible to provide the requested information. In line with your rights under section 1(1)(a) of the Act to be informed whether information is held, we confirm the ICB does not hold any of the information requested.

The North East and North Cumbria Integrated Care Board (NENC ICB) does not hold the records which you have sought for County Durham and Tees Valley places. However, we have determined the records are held by Tees, Esk & Wear Valley NHS FT ((TEWV) tewv.foi@nhs.net)

In accordance with our duty under s.16 of the FOIA to provide reasonable advice and assistance to an individual requesting information, we have provided the FOI email address for CNTW to make your request.

Newcastle place

Response 7 and 9: We commission Northeast Autism Society to deliver a children and families autism hub (pre and post diagnostic support). Families are also signposted to children and families early help hubs. Our Children's IAPT 'Getting Help' is available for first and second tier mental health support. Families can also access the Local Offer to see what other supports are available.

Response 8: Tyneside Mind have an adult's autism support service in Newcastle. We will be commissioning an Adult Autism Hub this year in Newcastle. Skills for people offer support to autistic adults and the ICB funds some of that support.

Response 10: It would depend on what the person's support needs were.

Gateshead, North Cumbria, Northumberland, Sunderland, South Tyneside places
