<u>Freedom of Information Act 2000 – Request for Information – NHS North East and North</u> <u>Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 4 March 2025 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

Your Request

I am submitting a Freedom of Information request under the Freedom of Information Act 2000 regarding NHS dental contract payments. I would like to request the following information for the North East and Cumbria region:

- 1. Clarification if the minimum UDA rate uplift of £31.46 has been paid to contract holders in this region for the 2024/25 financial year as part of the local action towards the national dental recovery plan.
- 2. Confirmation of whether the 4.64% pay uplift has been applied on top of the minimum UDA rate uplift.
- 3. Any documentation or policy guidance related to UDA rate adjustments for this period.

Our Response

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB does hold the information requested.

- 1. The local minimum Unit of Dental Activity (UDA) rate of £31.46 has been all applied to all relevant NHS General Dental Service contracts backdated to 1 April 2024.
- 2. 4.64% has subsequently been added to all General Dental Services contracts by the NHS Business Services Authority in line with the nationally agreed uplift.
