## Freedom of Information Act 2000 - Request for Information - NHS North East and North **Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received by North of England Commissioning Support (NECS) on 5 February 2025 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

## **Your Request**

Please release the following information under the terms of the Freedom of Information Act.

Following the government's £100 million funding for adult and children's hospices in the UK, did the government provide any requirements for what the money should be spent on for Hospices in the North East of England?

## **Our Response**

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB does hold the information requested.

To date there has been no detail provided on the proposed funding for hospices that the FOI request references. There has been no further clarity through the recent NHSE planning guidance.
