<u>Freedom of Information Act 2000 - Request for Information - NHS North East & North Cumbria Integrated Care Board.</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 16 February 2023 for information held by NHS North East and North Cumbria Integrated Care Board (ICB) under the provisions of the Freedom of Information Act 2000.

For information Clinical Commissioning Groups ceased to exist on 30 June 2022. Services that were previously delivered by the CCG are now being delivered by the successor organisation NHS North East and North Cumbria (ICB). This covers the areas of County Durham, Newcastle Gateshead, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland and Tees Valley.

Please find the information you requested on behalf of the ICB as follows.

Request in bold and response in italics

Please provide clarification and confirmation that the ICB FOI response to me is correct and that of the Contractor Northumberland Health is incorrect.

The private minutes of the ICB provided to me by FOI and the minutes of the NCC planning meeting available online, both confirm a merger has taken place.

An administrative merger has taken place. Which resulted in the formation of the Lindisfarne Partnership as an administrative body that provides back-office functions to the GP practices forming the Lindisfarne Partnership.

The ICB FOI response clearly states the four contracts are held by Lindisfarne Health. The Facebook surgery clarification and the public meeting discussion directly contradicts this.

The FOI response and the Facebook surgery post states that Lindisfarne Health is a Partnership, and that the partnership holds four contracts.

The Lindisfarne Partnership is an administrative body and does not hold the contracts. Separate GP contracts remain, but all GPs on the Lindisfarne Partnership are named on each of the separate GP contracts.

Assura told me directly that their contract would be with Dr Lees.

It is the ICBs understanding that at this time that the signatories to the contract are yet to be agreed by the GP Partners for Northumberland Health GP contract. Assura has stated to the ICB they require at least 2 signatories to the contract. This is for the Lindisfarne Health partners to determine.

Whichever, partner or partners sign the lease agreement will do so on behalf of all partners named on the GP contract, and responsibility for the lease will be outlined in the Partnership Agreement.

The contractual arrangements are clear in that four GP contracts remain, the relationship between the GPs named on those contracts is in line with the administrative merger and the Lindisfarne Health Partnership.

I would like copies of the latest PIDS for this new Felton surgery project as well as a copy of the revised District valuers report, as I understand that new terms have been agreed with Assura for the lease of the building once built due to inflationary build costs.

There is no revised PID for the Felton Surgery project, the new Felton surgery rent has been agreed as set out in the original PID. Any increase in rent subject to building costs will be supported under direction 6 of the premises cost directions with the guidance of the District Valuer.

In line with the Information Commissioner's directive on the disclosure of information under the Freedom of Information Act 2000 your request will form part of our disclosure log. Therefore, a version of our response which will protect your anonymity will be posted on the NHS ICB website https://northeastnorthcumbria.nhs.uk/.
