## Freedom of Information Act 2000 - Request for Information - NHS North East and North **Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received by North of England Commissioning Support (NECS) on 11 April 2024 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the 5 councils that make it up - Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

## **Your Request**

I am writing to request the following information under the terms of the Freedom of Information Act (2000). For the twelve months from January 2023 to January 2024, please provide a breakdown of the following:

- 1. The number of pharmacies which permanently closed in your Integrated Care System.
- 2. The number of temporary pharmacy closure days recorded in this period, per pharmacy.
- 3. The duration of closures on each day, per pharmacy.
- 4. Reasons provided for closures at each pharmacy.

I would like you to provide this information via email. Please do not hesitate to contact me should any aspect of my request require clarification.

## **Our Response**

There have been 25 pharmacy closures across NENC ICB in the twelve months between 1 January 2023 and 31 December 2023. There have been 1438 temporary closures notifications submitted by 167 pharmacies, in the twelve months between 1 January 2023 and 31 December 2023.

The attached file details the duration and rationale for these closures.
