Freedom of Information Act 2000 - Request for Information - NHS North East and North **Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received on 20 June 2025 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000. The ICB covers the areas of County Durham, Newcastle Gateshead, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley.

Please find the information you requested on behalf of the ICB as follows.

Your Request


Under the Freedom of Information Act 2000, I request the following information regarding the Independent Oversight Group (IOG) overseeing the North East Ambulance Service (NEAS):

- 1. Minutes or notes for the IOG meetings held on 22 November 2023, 21 February 2024, and 20 March 2024, as confirmed by NEAS board papers (2023–2024), and the ICB's 17 January 2024 minutes.
- 2. The IOG report (July 2024), which summarises the IOG's activities and findings.
- 3. Records of family engagement activities related to the IOG (e.g., invitations, correspondence sent to family representatives), particularly for October 2023 to April 2024, given reported family disengagement in early 2024 (Chronicle Live, 6 August 2024).
- 4. Details of the appointment process for IOG Chair Graham Prestwich, including any conflict-ofinterest assessments, given his NHS affiliations.
- 5. Any NEAS board papers (2023–2024) held by the ICB that reference IOG meetings or its activities.

These records are essential to assess the transparency of the IOG's oversight of NEAS's response to the Griffiths review (July 2023). The NEAS scandal, involving allegations of cover-ups and governance failures (Chronicle Live, 24 July 2024 and 6 August 2024), has generated significant public interest, and the ICB's role in ensuring accountability justifies this request. incomplete response to my previous FOI (FOI ICB 25–058) omitted these items, prompting this specific request to address unresolved gaps.

Please provide the information within 20 working days, as required by the FOIA. If any records are exempt, please specify the relevant exemptions and explain their application. I am happy to clarify or refine the request to reduce any burden.

Our Response

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB holds some of the information you have requested.

- 1. Redacted IOG minutes for the meetings dated 22 November 2023 and 21 February 2024 were sent to you in our original response, along with minutes dated 27 October 2023 and 17 January 2024. NENC ICB does not hold IOG meeting minutes dated 20 March 2024.
- We can confirm that NENC ICB does not hold a copy of the IOG report dated July 2024, however, the NEAS Independent Oversight Group – Final Report is available as part of the NEAS published Board papers of September 2024. A link to the papers is:
 Board Papers September 2024.pdf. The item starts on page 222.
- 3. We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB on this occasion is not able to provide the requested information. In line with your rights under section 1(1)(a) of the Act to be informed whether information is held, we confirm the ICB does not hold any of the information requested.
