## <u>Freedom of Information Act 2000 - Request for Information – NHS North East & North Cumbria Integrated Care Board.</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 25/09/2023 for information held by NHS North East and North Cumbria Integrated Care Board (ICB) under the provisions of the Freedom of Information Act 2000.

For information Clinical Commissioning Groups ceased to exist on 30 June 2022. Services that were previously delivered by the CCG are now being delivered by the successor organisation NHS North East and North Cumbria (ICB). This covers the areas of County Durham, Newcastle Gateshead, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland and Tees Valley.

Please find the information you requested on behalf of the ICB as follows.

## Request

I am emailing to request information under the Freedom of Information act. We note from freely available data that North Tyneside General Hospital utilises Acetic acid. Please could you provide the following information:

- 1) How many units of Acetic acid 1%, 3% and 5% did you use in 2022?
- 2) What volume is Acetic acid purchased in (e.g., 30ml or 100ml)?
- 3) How much did you pay for Acetic acid 1%, 3% or 5% in 2022?
- 4) What percentage of acetic acid used is sterile?
- 5) Do you know in which department acetic acid is used?

- 6) How many patients do you serve?
- 7) How many upper GI endoscopies do you do per year?
