<u>Freedom of Information Act 2000 – Request for Information – NHS North East and North</u> <u>Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 9 May 2024 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

Your Request

This is a Freedom of Information request in relation to commissioned NHS Adult Audiology services. Please could you respond to the six questions below?

- 1. In which localities / places do you currently commission an NHS Adult audiology service within your ICB geography?
- 2. For each locality / place, please could you confirm:
 - a. The name of each audiology provider;
 - b. The locations where they deliver this service.
- 3. Based on billing data for the last 3 months, please could you confirm the percentage share of the overall service volume for each audiology provider?
- 4. What are your timescales for ensuring the full-scale introduction of self-referral for commissioned NHS Adult audiology services for all localities/places in your ICB geography?
- 5. What are your plans for reviewing and improving wax removal provision across the ICB including patients with or without an associated hearing loss and do you have timescales in mind for introducing such a service?
- 6. Where the ICB holds multiple commissioned NHS Adult audiology service contracts at Place level what are the ICB's plans to rationalise and harmonise provision consistently across the geography, including tariffs, service specifications and inclusion/exclusion criteria?
