Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)

Thank you for your request received by North of England Commissioning Support (NECS) on 17 September 2024 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

Your Request

I am writing to you under the Freedom of Information Act to request information regarding gain-sharing agreements within your ICB for TNF-alpha biosimilars, such as infliximab, adalimumab, and etanercept. Could you please provide the following information:

1. **Existence of Gain-Sharing Agreement:**
 - Does a gain-sharing agreement exist in your ICS for TNF-alpha biosimilars?
2. **If Yes:**
 - What is the length of the current gain-sharing agreement?
 - What percentage of the savings from this agreement is directly invested in the ICS or hospital?
 - Can you provide examples of where savings have been reinvested towards?
3. **If No:**
 - When did the last gain-sharing agreement end?
 - Are there any plans for new gain-sharing agreements in the future?

Our Response

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB does hold the information you have requested.

1. There is no gain sharing agreement for TNF-alpha biosimilars.
2. Please refer to the response to question 1.
3. The ICB has not had a gain-sharing agreement for TNF-alpha biosimilars and no current plans for any gain-sharing agreement for TNF-alpha biosimilars.
