Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)

Thank you for your request received by North of England Commissioning Support (NECS) on 5 April 2024 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the 5 councils that make it up – Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

Your Request

Please could I make the following request for information under the Freedom of Information Act.

1. The name of the Sexual Health Platform commissioned by the ICS / ICB? For example, INFORM Sexual Health provided by INFORM, Lillie provided by Idox and MAXIMS PreView solution provided by Maxims
2. The Name of the Provider of the Sexual Health Platform?
3. The start date and end date of the current contract?
4. The name and email of the person within the ICB/ICS that is responsible for The Sexual Health Platform?

Our Response

On this occasion it is not possible to provide the requested information. In line with your rights under section 1(1)(a) of the Act to be informed whether information is held, we confirm the ICB does not hold any of the information requested.

Although some specialised services are directly commissioned by integrated care systems (ICSs), and at the national level by NHS England, Local Authorities remain the responsibility for the commissioning comprehensive sexual health services including most contraceptive services and all prescribing costs. The contracts and service specifications are overseen by each of the commissioning local authorities, not by the ICB.

In accordance with our duty under s.16 of the FOIA to provide reasonable advice and assistance to an individual requesting information, we have provided the FOI email addresses for those local authorities to make your request.
