## <u>Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 9 July 2024 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

## **Your Request**

I would like to request the following information:

- In your ICB, what departments have access to the health care budget to supports individuals?
- What services fall under that Health care budget?
- How many times does your Panel meet to determine budget in a month?
- Who is the main contact for those services and what is their contact email address / telephone number?
- How much funding is available through your health care budget?
- What is the allocation of the health care budget to different services?
- Do you have a separate commissioning Team for Private Healthcare Budgets
- What are the teams contact details?
- Have you got a list of providers you share with families looking for support through their Private Healthcare Budgets?
- How would an organisation get added to the Private Healthcare budgets provider list?
- How much funding is currently available through PHB's?

## **Our Response**

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB does hold the information requested.

- In NENC ICB, these departments have access to the health care budget to supports individuals: CHC, Childrens Continuing Care. S.117, Wheelchair.
- The services that fall under the Health Care budget are residential care, home care, supported living, day care, respite care.
- The panel meets weekly to discuss high-cost cases. Those that do not require high-cost approval (over £75K) are approved on an as and when required basis by case workers.
- The Private Healthcare Budgets Teams main contacts are:

- The 2024/25 budget for Continuing Healthcare is £514m, S117 is £140m.
- The budget is not split by individual services, so NENC ICB is unable to provide the allocation
  of the health care budget to different services.
- There is not a separate commissioning team for Private Healthcare Budgets.
- Please refer to the response to the previous question.
- There is a list of providers that can be shared with families looking for support through their Private Healthcare Budgets.
- To be added to the Private Healthcare budgets provider list, an applicant would email in to each place office. The quality team will then run a series of compliance checks.
- The CHC PHB budget is £109.4m.
