<u>Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 15 December 2023 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the 5 councils that make it up – Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland, and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

Your Request

Under the Freedom of Information Act, I would like to request the following information regarding NHS Continuing Healthcare (CHC) packages for adults aged 18+ within your local ICB, except for questions 1, 2, 5 and 8 where information is required for both adults aged 18+ and children aged 0-18 years old.

Please provide the data for the following former CCGs that now make up the ICB: NHS North East and North Cumbria Integrated Care Board North Tyneside CCG Northumberland CCG Newcastle Gateshead CCG North Cumbria CCG Sunderland CCG

South Tyneside CCG County Durham CCG Tees Valley CCG

For clarity, CHC refers to the NHS Continuing Healthcare funding pathway. For further information please see: https://www.england.nhs.uk/healthcare/. Homecare refers to packages of care delivered in the individuals' own homes (not in care homes or residential facilities).

Please provide data for the following financial years: 2018/19, 2019/20, 2020/21, 2021/22, and 2022/23, except for questions 6 and 7 which also require a current snapshot, and question 8 which only requires data for 2022/23. If any data for 2022/23 is not available, please provide budgeted figures for the year or the latest snapshot data that is available.

Where possible, please kindly include responses on the attached spreadsheet.

- 1. Please could you supply the name, email address and telephone number of the commissioner with responsibility for packages of CHC funded home care for (a) adults aged 18+ and (b) children aged 0-18 years old.
- 2. Please provide the number of people in receipt of CHC funded home care packages (all active packages during the year including those which started prior) for (a) adults aged 18+ and (b) children aged 0-18 years old.
- 3. Please provide the total number of CHC funded home care hours delivered for adults aged 18+.
- 4. Please provide the ICB's total gross expenditure on CHC funded packages for adults aged 18+.
- 5. Please provide the ICB's total gross expenditure on CHC funded home care packages for (a) adults aged 18+ and (b) children aged 0-18 years old.
- 6. Please provide the lowest, mean and highest hourly rate for CHC funded home care packages for adults aged 18+ for 2018/19 to 2022/23, as well as a current snapshot.
- 7. Please provide the lowest, mean and highest weekly fee for CHC funded home care packages for adults aged 18+ for 2018/19 to 2022/23, as well as a current snapshot.
- 8. Please provide a list of the top 10 providers who received the greatest amount of funding from CHC funded home care packages. Please provide data for the last financial year 2022/23 for both (a) adults aged 18+ and (b) children aged 0-18 years old.
 - i. For each provider, please provide the number of CHC funded home care packages in 2022/23 (all active packages during the year including those which started prior).
 - ii. For each provider, please provide total expenditure in 2022/23 related to CHC funded home care.

Our Response

We have dealt with your request in accordance with your "right to know" under section 1(1) of the Freedom of Information Act 2000 (subsequently referred to as FOIA2000) which entitles you to be provided with information "held" by a public authority unless an appropriate exemption applies.

In line with your rights under section 1(1)(a) of the Act to be informed whether information is held, we confirm the North East and North Cumbria Integrated Care Board (NENC ICB) does hold some of the requested information.

As ICBs were first legally established on 1st July 2022, there is no collective data held by NENC ICB for NHS Continuing Healthcare (CHC) packages for financial years 2018/19, 2019/20, 2020/21, 2021/22, and 2022/23. The eight clinical commissioning groups were reorganised and amalgamated into one single organisation namely the NENC ICB in July 2022. We have determined the cost of finding, answering, and assembling the responses to each of your questions for the eight clinical commissioning groups (CCGs) for those specific dates, would exceed the cost limit of £450 for the NHS as specified in the Freedom of Information and Data Protection (Appropriate Limit and Fees) Regulations 2004.

S.12(1) of the FOIA provides that a public authority is not obliged to retrieve any of the requested information if the cost of locating, retrieving, and extracting information would exceed the "appropriate limit". The limit for the NHS equates to 18 hours' work and can relate to one request in its entirety or a series of linked requests.

Therefore, to locate, retrieve and extract the NHS Continuing Healthcare (CHC) packages for the requested years prior to July 22 would be for each of the eight former Clinical Commissioning Group would require a search of their own records to identify what information may fall within the scope of these questions. There is no central record where this information is held.

To estimate how long it would take for one former CCG to retrieve any relevant information we have consulted with each place who calculated it would take approximately 46.5 hours for finance and clinical CHC teams to complete for Tees Valley, Durham, Newcastle, Gateshead, Cumbria, North Tyneside and Sunderland. The request asks for information pertaining to 6 financial years, there are 8 questions with most having multiple parts. Separate reports would need to be produced for each financial year, adults and children's data are also held on separate reports and it would entail complex data analysis to be able to answer each of your specific questions.

In accordance with our duty to provide advice and assistance under s.16 FOIA 2000, we have estimated that we may be able to answer some elements of your request if they were refined to one specific former CCG, or topic or area or financial year. We should also point out we have estimated that any revised request submitted for CHC funding data for all the former eight clinical commissioning groups (CCG's) would also exceed the appropriate limit for the required earlier years. Should you refine your request for data for one specific former CCG for all requested years or for one specific year for all CCG's we may be able to provide this within the appropriate limit of 18.5 hours. However, we should advise that we have not yet considered whether any exemptions to disclosure may apply to such future requests.

Please note that for South Tyneside and Northumberland places, this information is not held by NENC ICB who commission for South Tyneside Council and Northumberland County Council to now manage their CHC cases. Their contact details are provided below:

If you were to resubmit a revised request for information, we would treat this as a new FOI request, and the 20-working day limit will begin again. In accordance with s.17 FOIA 2000, this letter represents a refusal notice.
