# Freedom of Information Act 2000 - Request for Information - NHS North East and North **Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received on 16 June 2025 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000. The ICB covers the areas of County Durham, Newcastle Gateshead, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley.

Please find the information you requested on behalf of the ICB as follows.

# **Your Request**

I am writing to you under the Freedom of Information Act 2000 to request the following information from your organisation. Please may you provide me with an answer to the following:

- 1. Do you commission Community Dermatology Services in your ICB?
- 2. If so, please can you provide details on the following:
  - a. Name of provider(s)
  - b. Locations they cover (i.e. do they cover the whole ICB area or are they commissioned for specific places/boroughs/local authority areas?)
  - c. How long they are contracted for
  - d. The value of the contract
  - e. How many patients they saw in the last full financial year (e.g. 2024/25)
- 3. Do you have a tele dermatology pathway? If so, who is commissioned to deliver that service?

## **Our Response**

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB holds some of the information you have requested.

  - d. The community dermatology service is included within the wider FT contract and is paid on a block basis with no breakdown available for individual service lines.
  - e. We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB on this occasion is not able to provide the requested information. In line with your rights under section 1(1)(a) of the Act to be informed whether information is held, we confirm the ICB does not hold any of the information requested. Please redirect your request to County Durham and Darlington NHS FT.
- 3. The only change to response provided in FOI ICB 24-412 is that there are now only 5 GPs with extended role in Dermatology service commenced in 2016.

## Newcastle Gateshead and Northumberland and North Tyneside places

- 3. There is a tele-Dermatology pathway in North Cumbria. The service is provided by North Cumbria Integrated Care NHS FT.

# South Tyneside and Sunderland place

In line with your rights under section 1(1)(a) of the Act to be informed whether information is held, we confirm the ICB does not hold any of the information requested.
- 3. County Durham and Darlington NHS FT provides the tele-dermatology pathway for Sunderland patients and some South Tyneside patients. The Newcastle upon Tyne Hospitals NHS FT provides the tele-dermatology pathway for some South Tyneside patients.

# Tees Valley place

# a. South Tees - Skin Clinical Assessment Service

- b. One Life Centre Middlesbrough, University Hospital of North Tees, University Hospital of Hartlepool
- c. Contract length is 5 years.
- d. The contract value is part of the block contract with the foundation trust.
- e. South Tees Hospitals NHS Foundation Trust saw 3685 new patients.

#### a. Ramsay Healthcare – Dermatology

- b. The service is provided at the Tees Valley hospital site, Acklam Middlesbrough.
- c. Contract length is 3 years.
- d. The dermatology contract value not known as this is part of the overall contract value.
- e. The number of patients seen is not reported.

## a. Dr Thakur – The Headland Medical Centre Hartlepool

b. The service is provided in Hartlepool (Minor Skin Surgery).

- c. Contract length is 1 year.
- d. Activity base contract procedure price in 2024/25 is £101.75.
- e. There were 239 procedures carried out in 2024/25.
- 3. There is a tele dermatology pathway in Tees Valley. South Tees Hospitals NHS Foundation Trust and Ramsey Tees are commissioned to deliver the service.
