# Freedom of Information Act 2000 - Request for Information - NHS North East and North **Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received by North of England Commissioning Support (NECS) on 28 March 2025 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

### **Your Request**

I am writing to you under the Freedom of Information Act 2000 to request the following information from your trust. Please may you provide me with an answer to the following:

Does your ICB currently commission Tier 3 weight management services?

### If yes:

- a. How much did your ICB spend on Tier 3 weight management services in the last full financial
- b. Which provider(s) is/are commissioned to provide your Tier 3 services?
- c. On what basis are they commissioned (e.g. part of acute contract, AQP, Direct Award etc) and when does the contract expire?
- d. How many patients are your Tier 3 services commissioned to provide care for annually (by provider, if there are multiple)?
- e. Do you commission a Tier 3 weight management service giving patients the option of accessing the majority or entirety of their remotely, e.g. through Zoom calls or a digital platform?

- f. If not, do you have any plans to provide a remote/virtual/digital service in 2025/26?
- g. Can patients be referred to your Tier 3 weight management services via patient choice?
- h. Who in your organisation is responsible for the commissioning of weight management services? Please provide their name, position and contact details where possible?

## **Our Response**

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB holds some of the information you have requested.

Yes, NENC ICB currently commissions Tier 3 weight management services. This will continue through 2025-26.

- a. For the 2024-25 financial year, North-East and North Cumbria ICB spent £1,079k on Tier 3 weight management services.
- b. The providers commissioned to provide Tier 3 services are:

County Durham & Darlington NHS FT Newcastle Upon Tyne Hospitals NHS FT North Cumbria Integrated Care NHS FT Northumbria Healthcare NHS FT South Tees Hospitals NHS FT

- c. They are commissioned as part of Acute Contracts. The contracts expire on 31 March 2027.
- d. Payment is made as a block contract. NENC ICB does not hold information on patient numbers.
- e. NENC ICB does not commission a Tier 3 weight management service giving patients the option of accessing remotely.
- f. There are no plans to provide this remote service in 2025-26.
- g. No, patients cannot be referred to the Tier 3 weight management services via patient choice.
- h. The Healthier Weight and Treating Obesity Strategic Manager is responsible for the commissioning of weight management services. Please contact them via email using the address <a href="mailto:necsu.healthyweight@nhs.net">necsu.healthyweight@nhs.net</a>
