### <u>Freedom of Information Act 2000 – Request for Information – NHS North East and North</u> <u>Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 27 February 2025 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

## Your Request

1. Please disclose the number of mental health homicides (apparent/actual/suspected) reported to the ICB and/or its predecessor bodies in each of the years 2018/19, 2019/20, 2020/21, 2021/22, 2022/23, 2023/24 and 2024/25 YTD.

Please also give the total number of mental health homicides for the whole period 1 April 2018 to the present. By mental health homicides, I mean homicides committed by patients who are or have been in contact with mental health services.

2. Please disclose how many of the mental health homicides that were reported between 1 April 2018 and the present were independently investigated under HSG 94-27.
