# <u>Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 22 May 2023 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland and Tees Valley (which covers the 5 councils that make it up – Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

## **Your Request**

Please may I request the following information from your integrated care board. For ease of collation, the information could be provided in the tables provided after each question.

- 1. The numbers total of patients who have been prescribed antidepressants in the each of the years 2018, 2019, 2020, 2021, 2022 and 2023 so far.
- 2. The number of patients under the age of 18 who have been prescribed antidepressants in each of the same years.
- 3. The total number of patients under the age of 18 prescribed each of the following types of antidepressants in each of the same years

- 4. The number of patients under 18 who have been prescribed antidepressants in each of the same years, specifically as part of the treatment of Obsessive Compulsive Disorder and related symptoms.
- 5. The number of patients under 18 who have begun Talking Therapies ('psychotherapy') in each of the same years.

Antidepressants in this instance refers to any of the following classifications of drugs: SSRIs, SNRIs, NASSAs, TCAs, SARIs, MAOIs.
