Freedom of Information Act 2000 - Request for Information - NHS North East and North **Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received by North of England Commissioning Support (NECS) on 25 October 2024 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

Your Request

I am writing to request information under the Freedom of Information Act 2000 regarding General Ophthalmic Services (GOS) activity and Commissioned Enhanced Services (Optical) within North East and North Cumbria ICB.

NHS Sight tests

I would like to request the following data for the fiscal years 2022-23 and 2023-24:

- 1. Total Number of NHS Sight Tests: Please provide the total number of NHS sight tests conducted, along with the associated expenditure.
- 2. Domiciliary Sight Tests:
 - a. Number of domiciliary sight tests performed.
 - b. Percentage of total sight tests.
 - c. Associated expenditure for domiciliary tests.
- 3. Geographical Distribution: Please provide data on the geographical distribution of sight tests conducted within the ICB area.
- 4. Patient Outcomes: Any available data on patient outcomes related to General Ophthalmic Services (GOS) eg referrals to hospital eye services.
