Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)

Thank you for your request received on 17 December 2025 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000. The ICB covers the areas of County Durham, Newcastle Gateshead, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley.

Please find the information you requested on behalf of the ICB as follows.

Your Request

Under the provisions of the Freedom of Information Act 2000, I am writing to request detailed information regarding Adult Social Care expenditure within your Integrated Care Board (ICB) for the financial year 2025/26, with a particular focus on services for individuals with autism and learning disabilities (adults).

1. How much does the ICB spend overall per annum on Adult Social Care services? This would include annual recurrent budget for Adult Social Care services, plus non recurrent Service Development/Delivery Funding.
2. How much does the ICB spend per annum on learning disability and autism services for the following:
 - a. Acute care (this means care provided in hospitals including Assessment and Treatment Units)
 - b. Primary care
 - c. Community care (this means packages of care and support that are provided to people in homes in the community that are funded by the ICB or jointly funded with Councils)
3. Please tell us the uplift (expressed as a percentage) that you gave to providers for the 2025/26 financial year for packages of care and support provided to people with a learning disability

where these are jointly funded under the Better Care Fund (BHF) Section 75 arrangements or NHS Continuing Healthcare (CHC).

4. If you have a learning disability and autism strategy, please provide a link.

- c. Community care funding is £40,535,544 per annum. This figure covers County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, South Tyneside, Sunderland and Tees Valley for adults and all places for children. Northumberland adult information is held by Northumberland County Council.

4. NENC ICB does not have a learning disability and autism strategy.
