### <u>Freedom of Information Act 2000 – Request for Information – NHS North East and North</u> <u>Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 3 November 2024 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

## Your Request

I am writing to request information under the freedom of information act regarding your organisations Continuing Healthcare (CHC) and Domiciliary cases. Please can you answer the questions listed below.

- 1. How much did the ICB spend on Domiciliary care in the financial year 2023/24 (March 2023 April 2024)?
- 2. How much did the ICB spend on CHC in the financial year 2023/24?
- 3. How many Domiciliary care packages did the ICB have active at the end of September 2024?
- 4. What was the total cost of active Domiciliary care packages at the end of September 2024?
- 5. How many CHC cases did the ICB have active at the end of September 2024?
- 6. What was the total cost of active CHC packages at the end of September 2024?

## To clarify:

Question 1: The total spend on domiciliary care is in relation to fully funded CHC. Question 2: This in relation to fully funded CHC including the domiciliary care spend in Q1. Questions 4 and 6: Yes, this is this total annual cost of the active packages as at 30/09/2024.

## Our Response

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB holds some of the information you have requested.

## County Durham, Newcastle Gateshead, North Cumbria and Tees Valley places

- 1. The ICB spend on domiciliary care in the financial year 2023/24 was £61.8m.
- 2. The ICB spend on CHC in the financial year 2023/24 was £202.5m
- 3. The ICB had 675 active domiciliary care packages at the end of September 2024.
- 4. Total cost of active domiciliary care packages at the end of September 2024 was £60.8m.
- 5. NENC ICB had 2490 active CHC cases at the end of September 2024.
- 6. Total cost of active CHC packages at the end of September 2024 was £197.6m.

## North Tyneside and Northumberland and South Tyneside and Sunderland places

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB on this occasion is not able to provide the requested information. In line with your rights under section 1(1)(a) of the Act to be informed whether information is held, we confirm the ICB does not hold any of the information requested for the ICB places named above. However, we have determined that the information is held by the Local Authorities within these localities in the North East and North Cumbria region.
