<u>Freedom of Information Act 2000 - Request for Information – NHS North East & North Cumbria Integrated Care Board.</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 30 March 2023 for information held by NHS North East and North Cumbria Integrated Care Board (ICB) under the provisions of the Freedom of Information Act 2000.

For information Clinical Commissioning Groups ceased to exist on 30 June 2022. Services that were previously delivered by the CCG are now being delivered by the successor organisation NHS North East and North Cumbria (ICB). This covers the areas of County Durham, Newcastle Gateshead, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland and Tees Valley.

Please find the information you requested on behalf of the ICB as follows.

Your Request

I would like to request the FOI email addresses for all of the sub-ICB locations (SICBLs) within the ICB. This is to address situations where data is not held by the ICB and so there is a need to request information at SICBL level rather than ICB level.

Our Response

NHS North East and North Cumbria Integrated Care Board (NENC ICB) FOI requests are processed by North of England Commissioning Support (NECS). As such, there is only one email address for requests which is necsu.icbfoi@nhs.net

Any requests for information held by the sub-ICB locations (i.e. former CCGs or ICB places) are collated via the NECS Information Governance Team and responded to accordingly.
