Freedom of Information Act 2000 - Request for Information – NHS North East & North Cumbria Integrated Care Board.

Thank you for your request received by North of England Commissioning Support (NECS) on 28 September 2022 for information held by NHS North East and North Cumbria Integrated Care Board (ICB) under the provisions of the Freedom of Information Act 2000.

For information Clinical Commissioning Groups ceased to exist on 30 June 2022. Services that were previously delivered by the CCG are now being delivered by the successor organisation NHS North East and North Cumbria (ICB). This covers the areas of County Durham, Newcastle Gateshead, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland and Tees Valley.

Please find the information you requested on behalf of the ICB as follows;

Request

I have been informed by NHS England that you are best placed to give me the information I require about the above illness under the F O I act.

I would like to know how many cases of the above illness have been recorded in the 10 yrs in the run up to Covid. I would like the information broken down by age & gender. I live in Durham DH1 post code.

Response

On 29 September we asked you to clarify if you were only requesting this information for the County Durham area or for all areas of NHS North East and North Cumbria Integrated Care Board (NENC ICB) however we did not receive a response from you. As such we have provided you with the information for all areas of the ICB including County Durham in the attached spreadsheet.

In line with the Information Commissioner's directive on the disclosure of information under the Freedom of Information Act 2000 your request will form part of our disclosure log. Therefore, a version of our response which will protect your anonymity will be posted on the NHS ICB website <https://northeastnorthcumbria.nhs.uk/>.
